1. I am a Vice President at U.S. Bank National Association. U.S. Bank National Association, solely in its capacities as trustee, securities administrator, paying agent, and/or calculation agent (as named in such role or as successor to the named party, the “Petitioner”) filed an amended petition (the “Amended Petition”) in the above-captioned matter on December 28, 2021 with respect to the seventy-seven residential mortgage-backed securitization trusts (including any individually designated loan groups therein, the “Subject Trusts”) listed on Exhibit A to the Amended Petition. 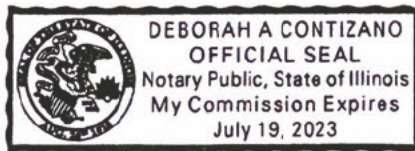
