WHEREAS, on July 25, 2025, the Court entered a Case Scheduling Order (NYSCEF Doc. No. 373) directing the parties in this case to submit a stipulation indicating that this case should be stayed upon full submission of the appellate briefing of the Wells Appeal by a date acceptable to this Court;
