

Specifically, some of the contractual provisions at issue here concerning the treatment of certain funds are very similar to contractual provisions at issue in the WF Art. 77. Additionally, the trusts at issue in this proceeding are similar to the trusts at issue in the Wells Fargo Art. 77, and both the Wells Fargo Art. 77 and this case implicate questions concerning an order issued in JPM II.
