WHEREFORE, I respectfully request that the application for my admission *pro hac vice* be granted.

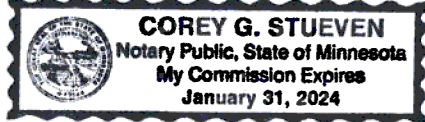


